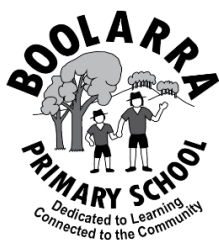
What type of online services are used at our school?

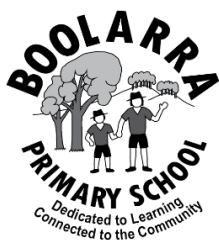

What content and materials will be shared through the software?

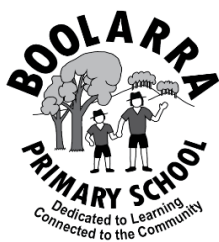
